4. The following activities are excluded from the school programme:

Grade 6 Tour (depending on circumstances)

5. The school will be a fee-paying school and school fees have been determined and levied in accordance with the provisions of Section 38 and 39(1) of the South African Schools Act.

- The proposed school fee for 2021 of R 9 500.00 has been approved for Grade 1 – 7.

- The proposed school fee for 2021 of R 9 900.00 has been approved for Grade R.

- If a parent has one child at the school, the parent pays the full amount of R 9 500.00.

If you have two children, the one child pays the full amount and the second child gets a discount of 5%.

If you have three children, the first child pays the full amount, the second child gets 5% discount and the third child receives 7.5% discount.

10% discount will apply to every fourth child and every child thereafter.

- The above school fee is determined in terms of the above SASA Act and is in relation or participation of the learner in any of the school **programme** as defined and approved by the parents.

- All other programmes or activities as defined and approved are not part of the school programme are voluntary and carry no additional cost.

- School fees must be paid in full by 31 October 2021 (Grade 1 – 7) in which case a discount of (10 %) will be granted if paid in full before 28 February 2021, for the first child and 31 March 2021 for the second child and 30 April 2021 for the third child.

- Fees may be paid in 10 equal instalments (R 950.00) commencing on the 1st January 2021 and ending the 31 October 2021. (Grade 1 – 7)

- Fees may be paid in 11 equal instalments (R 900.00) commencing on the 1st January 2021 and ending the 30 November 2021. (Grade R)

- If any instalment is outstanding by the due date the full outstanding amount school fees will become due and payable.
 - A parent's school fee debt (to the extent that he has been exempted) is a statutory obligation and thus takes priority over other voluntary debts as listed under voluntary programmes. Money received will first be allocated to school fees.
 - The school can record the non-performance on school fee obligation to a bureau.
 - The school has the right to verify all information supplied to them.
6. All parents shall be obligated to pay school fees in terms of section 40 of the South African Schools act, unless they have been granted exemption from the payment of school fees. The criteria for the total, partial or conditional exemption of parents, who are unable to pay compulsory school fees, be determined in accordance with the criteria set out in *The Exemption of Parents from School Fees Regulations (as amended in Government Gazette 39392 of 17 November, 2006.*
6. The proposed appointment of additional staff, and payments in terms of Section 38A of the South African Schools Act have been approved.
